2. Quotations/e-tenders are invited for the auction/disposal of the aforesaid vehicle on the terms & conditions mentioned below. Firms/Persons interested to buy the aforesaid vehicle are required to submit their highest quotation in the enclosed proforma (Annexure-A), addressed to Chief Manager (P&A), National Handicapped Finance and Development Corporation, Unit No. 11 & 12, Ground Floor, DLF Prime Tower, Okhla Phase-I, New Delhi-110020 upto 01.00 P.M. by 25<sup>th</sup> March, 2019.

The quotations/tenders received will be opened by the Tender/Purchase committee at 4.00 PM on the same day i.e. 25/03/2019. The vehicle is available for inspection from 11.00AM to 3.00 PM on all working days from 15/03/2019 to 24/03/2019 at National Handicapped Finance and Development Corporation, Unit No. 11 & 12, Ground Floor, DLF Prime Tower, Okhla Phase-I, New Delhi-110020.

3. The interested Bidders may submit their bid application alongwith an Earnest Money Deposit of Rs. 10,000/- (Rupees Ten thousand only) by way of Demand Draft/Pay Order in favour of "National Handicapped Finance and Development Corporation payable at New Delhi. The quotations/ tenders received without Earnest Money Deposit (EMD) will not be considered and shall not be accepted by this Corporation.

4. The quotations received in time will be opened at National Handicapped Finance and Development Corporation, Unit No. 11 & 12, Ground Floor, DLF Prime Tower, Okhla Phase-I, New Delhi-110020 at 4.00 PM on 25/03/2019. The Bidders or their representative (not more than one) may be present, if they so desire at the time of opening of quotations.

5. The auction will be governed by the following conditions:-

(i) The successful bidder will be required to deposit the balance bid amount after deducting earnest money of Rs.10000/- within one week of opening of bids by of Demand Draft in favour of "National Handicapped Finance and Development Corporation payable at New Delhi".

- (ii) The delivery of the sold vehicle will be given only after the successful bidder submits documentary evidence in support of residential status (Aadhar Card/Voter Identity Card) in case of Individual and Registration Certificate in case of firm etc.). The successful bidder has to take the delivery of vehicle from National Handicapped Finance and Development Corporation, Unit No. 11 & 12, Ground Floor, DLF Prime Tower, Okhla Phase-I, New Delhi-110020 at their own expenses.
- (iii) Disputes, if any shall be subject to Jurisdiction in the Court of Delhi only.
- (iv) The vehicle will be disposed off on **“as is where is basis”** and no guarantee for its worthiness or quality will be given by this Corporation.
- (v) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. The NHFDC will not be responsible for any lapse on his part in this regard. The Original Registration Certificate of the vehicle will be provided to the successful bidder, on receipt of full & final payment.
- (vi) The successful bidder shall not be allowed to withdraw his bid and in the event of his withdrawing from the bid, his earnest money will be forfeited.

1. The Vehicle will be sold to the highest bidder as and where basis.
2. The Auctioneers (NHFDC) reserve the right to refuse the bid of any person and that without any reason. The Auctioneers reserve the right to bid as agent for any prospective buyer and further reserve to themselves the right to regulate the bidding and the conduct of the sale. Their decision on all matters affecting the sale shall be final and binding.
3. The bidder must enclose the earnest money Rs.10,000/- (Rupees Ten Thousand only) through Demand Draft in favour of National Handicapped Finance and Development Corporation alongwith the quotation, the quotation will not be valid without earnest money.

4. The cost of the Vehicle {WAGON-R VXI Car (DL-2C-AG-9955) is fixed (minimum) with the reserve price of Rs.25,000/-(Rupees Twenty Five Thousand only), the quotation will be invalid, if the price of the vehicle is quoted less than Rs.25,000/-.
